LeRay Housing incurred \$1,023.63 in penalties across their 300 accounts due to late payment of April 2025 utility bills. Management from LeRay Housing stated the delay was caused by a change in their email address, which resulted in missed communications and billing notices. LeRay Housing has formally requested that the penalties be waived. With four (4) board members present, the vote resulted in a tie. Due to the split vote, the motion was tabled until the next scheduled board meeting.

Clerk Verne presented a proposal to the Town Board to shift the processing of the 2nd and 3rd installments of Town/County Property Taxes to the Jefferson County Treasurer's Office. After discussion, the Board agreed that this change would be beneficial to the Town and approved the proposal.

A motion was made by Councilman Biondolillo and seconded by Councilman Gracey to authorize the Town of LeRay Clerk's Office to continue collecting full property tax payments and 1st installments, and to shift the collection of 2nd and 3rd installment payments for Town and County taxes to the Jefferson County Treasurer's Office, to begin with the 2026 Tax Collection.
