A motion was made by Biondolillo and seconded by Gracey that the board approves \$800.00 to help with the Cool Yule this year. Carried Ayes 4 Nay 0.

Public hearing having been held at 4:10 p.m. to hear comments on the Fire and Ambulance Contracts for the year 2020. No one commented. Immediately following a public hearing was held on the Preliminary Budget for the year 2020. No comments. Hearing Closed.

A motion was made by Biondolillo and seconded by Gracey that the board approve the Fire and Ambulance Contract as follows: Black River Vol. Ambulance Squad, \$40,000, Evans Mills Vol. Ambulance \$50.000, Black River Fire Dept. \$100,000 and Pamelia Vol. Fire Company \$16,650. Carried Ayes 4 Nay 0.

A motion was made by Biondolillo and seconded by Gracey that the board adopt the preliminary budget as the Annual Budget for the year 2020. Carried Ayes 4 Nay 0.

Public hearings were held at 4:15 p.m. for three Local Laws each following the other, Local Law #4 was to amend and restate Local Law #1 of 2019 as it relates to Water and Sewer Rate for the year 2019, Local Law #5 to amend and restate Chapter 158 of the Code of the Town of LeRay as the same relates to Non-conforming free standing signs, and Local Law #6 to Opt Out of Section 487 of the Real Property Tax Law. No comments. Hearing closed.

A motion was made by Gracey and seconded by Shawcross that the board approves Local Law #4-2019 Water and Sewer Rates. Carried Ayes 4 Nay 0.

A motion was made by Gracey and seconded by Shawcross that the board approves Local Law #5-2019 Non-conforming free standing signs. Carried Ayes 4 Nay 0.

A motion was made by Biondolillo and seconded by Gracey that the board approves Local Law #6-2019 Opt Out of Section 487 of the Real Property Tax Law. Carried Ayes 4 Nay 0.

Mike Altieri and Victoria Reagan from BCA gave report on LeRay II water tower and new highway barn.

Lee Shimel, ZEO gave monthly report. Solar is becoming requested more and we should be looking into stronger zoning laws. He is also requesting a Road Use Agreement for these big solar projects to protect our roads and also to increase zoning permit fees.

A motion was made by Biondolillo and seconded by Shawcross that the board requests the Planning Board to look at our zoning laws pertaining to solar and rate fees and comment back to the town board. Carried Ayes 4 Nay 0.

Steve Marshall, DANC gave monthly report, the electrical panel at Farash pump station needs to be replaced soon he stated that it will probably be about \$9500-10,000 to replace it.

A motion was made by Biondolillo and seconded by Gracey to authorize Supervisor Taylor to sign Abstractor Agreement regarding stub searched for Water District #4 easements in connection with LeRay II water tower project. Carried Ayes 4 Nay 0.
