Town of LeRay Local Law No. 4 of the year 2022

A Local Law to Amend Section 158-99 of the Town Code of the Town of LeRay

Be it enacted by the Town Board of the Town of LeRay as follows:

Section 1. Authority.

This Local Law is adopted pursuant to the authority of the Municipal Home Rule Law of New York State and the Town Law of New York State.

Section 2. Amendment.

Section 158-99 of the Code of the Town of LeRay shall be amended by adding the following subsection to read as follows:

H. Nonresidential uses within a R-1 Single Family Residential District are permitted in conformance with Table 6. Freestanding signs shall be limited to one per property held in a single and separate ownership, except for a property that has frontage on more than one street, in which case one such sign shall be permitted for each separate street frontage. Multi-use or multi-tenant properties may have one free standing sign per street frontage. Changeable signs are permitted on freestanding signs other than plaza directory signs, with content changes limited to twice daily (e.g., fuel price signage).

Section 3. Amendment to Table.

Table 6 shall be amended to read as follows:


