Steve Marshall, DANC reported that the second pump at the Woodcreek pump station is down, to get it repaired would cost \$7800 a new pump would cost \$8800.

A motion was made by Gracey and seconded by Biondolillo to approve the purchase of a new pump in the amount of \$8800. Carried Ayes 5 Nay 0.

Last year we approved the purchase of two automatic flushers in the amount of \$4916.00, due to having watermain breaks they were not purchased. A motion was made by Biondolillo and seconded by Gracey that the board authorize the purchase of the two automatic flushers. Carried Ayes 5 Nay 0.

A motion was made by Biondolillo and seconded by Shawcross that the board set a fee for filling pools. The rate will be the 1.5 hr for the lead operator to install and uninstall meter to hydrant and the water usage rate per district. The only one to fill pools will be a person from a fire department. Carried Ayes 5 Nay 0.

A motion was made by Gracey and seconded by Biondolillo that the board passes a fund balance policy in accordance with GASB Statement No. 54. Carried Ayes 5 Nay 0.

A motion was made by Gracey and seconded by Biondolillo that the board adopt conditional negative declaration to SEQR for the SD #1 project and determined it a type one action. Carried Ayes 5 Nay 0.

A motion was made by Gracey and seconded by Biondolillo that the board adopt the Bond Resolution authorizing the issuance of serial bonds or a statutory Installment Bond not exceeding \$150,000.00 for improvements of SD#1. Carried Ayes 5 Nay 0.

A motion was made by Biondolillo and seconded by Gracey that the board goes into executive session at 5:00 p.m. to discuss pending litigation. Carried Ayes 5 Nay 0.

A motion was made by Gracey and seconded by Biondolillo that the board returns to regular session at 5:50 p.m. Carried Ayes 5 Nay 0.

A motion was made by Shawcross and seconded by Gracey that the board adjourns meeting at 5:55 p. m. Carried Ayes 5 Nay 0.
