A motion was made by Biondolillo and seconded by Eisenhauer to adopt the minutes of the regular meeting held on December 10, 2020. Carried Ayes 4 Nay 0.

Dan Young, Highway Superintendent gave his monthly report. Reported that the FlexPro snowplow blades were working well. He also requested to purchase a used 2002 John Deere loader that was owned by the Town of Worth for \$27,000. He would like to trade years with the purchase of the loader instead of the ³/₄ ton pickup with plow and purchase the truck in 2023. A motion was made by Gracey and seconded by Biondolillo to make the purchase. Carried Ayes 5 Nay 0.

A public hearing was held at 4:10 p.m on proposed Local Law 1-21 to hear comments on water and sewer rates for the year 2021 as follows:

- Water District #1 Effective February 1, 2021- .00330 per gallon O&M charge-metered water usage billed quarterly with a minimum charge of \$26.50 and a 3% per quarter penalty after 30 days from billing date.
- Water District #2 Effective January 1, 2021- .00330 per gallon charge-metered water usage billed quarterly with a combined minimum charge of \$26.50 and a 3% per quarter penalty after 30 days from billing date.
- Water District #3 Effective March 1, 2021- .00575 per gallon charge-metered Water usage billed quarterly with a minimum charge of \$26.50 and a 3% per quarter penalty after 30 days from billing date.
- Water District #4 Effective March 1, 2021- .00330 per gallon O&M chargemetered water usage billed quarterly with a minimum charge of \$26.50 and a 3% per quarter penalty after 30 days from billing date.

Sewer District #1 – Effective January 1, 2021 - .00760 per gallon sewer rate based

on metered water usage billed quarterly with a minimum charge \$15.00 and a 3% per quarter penalty after 30 days from billing date.

Sewer District #2 – Effective March 1, 2021 - .00760 per gallon sewer rate based on metered sewerage flow billed quarterly with a minimum charge of \$15.00 and a 3% per quarter penalty after 30 days from billing date.

Sewer District #3 – Effective February 1, 2021 - .00300 per gallon sewer rate based on metered water usage billed quarterly with a minimum charge of \$60.25 and a 3% per quarter penalty after 30 days from billing date.

Sewer District #4 – Effective March 1, 2021 -.00300 per gallon O&M chargemetered water usage billed quarterly with a minimum charge of \$48.00 and a 3% per quarter penalty after 30 days from billing date.

Mr. Eisenhauer expressed his concerns to Mrs. Biondolillo regarding the proposed solar law. Mrs. Biondolillo acknowledged the concerns and said she would take the comments into consideration.

A motion was made by Biondolillo and seconded by Carpenter that the board has reviewed and agreed with SEQR and to declare a negative declaration. Carried Ayes 5 Nay 0.

A motion was made by Eisenhauer and seconded by Biondolillo that the board approve Local Law #2-21 Solar Law as presented. Carried Ayes 5 Nay 0.

Mike Altieri, BCA gave monthly report on New Highway Facilities and water tower project. Close to getting them ready for bidding.

William Vargulick, Assessor presented a resolution to adopt provisions of executive order 202.83 Suspending the requirements of renewal applications as a condition to granting exemptions under section 459-c and 467 of the Real property laws.
